7 **David Stafford Johnson**

8 David Stafford Johnson is a member of On Systems Technology. Mr. Johnson  
9 appeared by telephone at the pre-hearing conference, and responded to Judge Dion's questions  
10 by providing the following information:

- 11 ▪ Full name;
- 12 ▪ Current address;
- 13 ▪ Current telephone number
- 14 ▪ A statement that he understood that if he were not represented by counsel and  
15 did not represent himself in the above-captioned proceeding, or chose not to  
16 appear to present evidence on his behalf, the Commission may proceed against  
17 him in absentia and may enter a default judgment against him; and
- 18 ▪ That his interests and the interests of On Systems Technology may be divergent,  
19 such that there may be a conflict between him and On Systems Technology  
20 which would necessitate separate counsel for On Systems Technology and for  
21 himself. (See Transcript of June 5, 2003 Procedural Conference, at 26.)

24 Out of an abundance of caution, Mr. Glaser sent Mr. Johnson an affidavit confirming  
25 these statements, to be executed before a notary public. Mr. Johnson is expected to return the  
26 executed affidavit to Mr. Glaser by June 26, 2003 for filing with the Commission.

**Tim Wetherald**


Mr. Wetherald provided an affidavit with the information requested by Judge Dion, and it was filed with the Commission on Monday, June 23, 2003. Copies of Mr. Wetherald affidavit were provided to the presiding judge and to Staff by facsimile on June 20, 2003.

**Frank Tricamo**

Counsel has had difficulty in locating Mr. Tricamo. Mr. Tricamo is not (and has not been) active in the management of On Systems Technology. Mr. Tricamo's address and telephone number are not maintained in any telephone directory available in the Denver metropolitan area, and Mr. Tricamo maintains an unpublished telephone number. Counsel made a number of attempts to contact Mr. Tricamo through On Systems Technology, but has been unsuccessful because Mr. Tricamo is not active in On Systems Technology management. Beginning June 6, 2003, undersigned counsel enlisted the specific assistance of Mr. Tim Wetherald, a member of On Systems Technology and Manager of The Phone Company Management Group, LLC ("PCMG"), in an attempt to locate Mr. Tricamo. On June 13, 2003, Mr. Wetherald finally provided undersigned counsel with Mr. Tricamo's address and telephone number, and undersigned counsel promptly contacted Mr. Tricamo on that day regarding the information requested by Judge Dion in the procedural conference held on June 5, 2003. Mr. Tricamo responded to counsel's contact on June 16, 2003, and subsequently provided counsel certain additional information to be included in an affidavit to be filed with the Commission. Undersigned counsel has provided Mr. Tricamo an affidavit containing the information requested by Judge Dion, plus the additional information requested to be included by Mr. Tricamo. Mr. Tricamo has indicated that he will either return the affidavit to undersigned counsel for submission to the Commission or file it directly with the Commission.

1 Undersigned counsel attempted to contact Mr. Tricamo on June 23, 2003, and left a message,  
2 but Mr. Tricamo has not returned the call.
