





1 Undersigned counsel hereby submits this Further Status Report to The Honorable Philip
2 J. Dion III, with respect to the filing of the Affidavit of Frank Tricamo.

3 On July 16, 2003, undersigned counsel provided Mr. Tricamo with a revised Affidavit
4 containing certain information Mr. Tricamo had requested be included, including the statement
5 that Mr. Tricamo had not been served with a copy of the Staff's Complaint of October 18, 2002,
6 and that he would respond to it if officially served. To date, Mr. Tricamo has not returned the
7 Affidavit executed for submission to the Arizona Corporation Commission ("Commission"),
8 but has indicated to undersigned counsel that if he were properly served with a copy of the
9 Staff's Complaint, he would respond to it. Undersigned counsel has concluded that Mr.
10 Tricamo does not intend to submit the Affidavit with the information requested by Judge Dion,
11 although Mr. Tricamo is aware of the information sought and the consequences of actions taken
12 by the Commission in the event he does not appear at the hearing set in the above-captioned
13 case.

17 counsel's Motion to Withdraw as counsel to all the parties indicated in undersigned counsel's
18 initial appearance submitted to the Commission on January 3, 2003, in the above-captioned
