FILE TRICAMO AFFIDAVIT


1 Undersigned counsel hereby submits this Supplemental Status Report to The Honorable
2 Philip J. Dion III, presiding judge in the above-captioned case, reporting the status of the filing
3 of the Affidavit of Frank Tricamo, a member of On Systems Technology, LLC, and a
4 respondent in the above-captioned proceeding.

5 Mr. Tricamo has not yet signed his Affidavit, but has requested that undersigned
6 counsel seek additional time so Mr. Tricamo can review his position, file the Affidavit
7 requested by Judge Dion, and retain new counsel. Mr. Tricamo intends on filing a Motion to
8 Dismiss himself as a respondent in the above-captioned proceeding, which will be supported by
9 his Affidavit with facts. This Affidavit will also contain the information requested by Judge
