For the record, GTECC has three pending applications for competitive telecommunications certificates of convenience and necessity ("CC&N"):

1. long-distance reseller (Docket No. T-⁰³²⁵⁸~~03528~~A-96-0492);
2. alternative operator services (Docket No. T-03528A-97-0568); and,
3. local resale and local facilities-based (Docket No. T-03528A-97-0545).

GTECC intends to update all three applications, as requested in your letter, with new contact personnel and financial data.
