To expedite the review of this information and accelerate the introduction of full telecommunication competition in Arizona, U S West ~~must~~ **is strongly encouraged** to file information related to a checklist item as soon as possible after it believes that it has satisfied the requirements of the specific item. Interested parties may then respond. Interested parties are not limited to responding to U S West. At any time, parties may file information related to specific checklist items or general market conditions.

**Page 3, Finding of Fact No. 6 (lines 3-5), modify as follows:**

2. ~~When~~ **As soon as possible** after U S West believes that it has satisfied a particular competitive checklist item, it should file with the ACC. Five business days prior to the filing, U S West should serve a notice of intent to file with each of the interested parties.

All interested parties may file information related to general telecommunications market conditions in Arizona at any time in this docket. **Interested parties are required to respond specifically to question 3, Attachment A, within 10 days of U S West's notification of its intent to file with the FCC.** However, U S West ~~is encouraged to provide such information~~ **must file all information responsive to Attachments A and B of this order no later than 45 90 days before its FCC filing.**
