**Sprint's Response to Question 3 of Attachment A**

Pursuant to the Commission's May 27, 1997, Order (Decision 60218) in this matter, Sprint Communications Company L.P. (Sprint) submits the following information in response to Question 3, Attachment A of that order:

1. Sprint Communications Company L.P. was certificated by this Commission to provide local exchange services and exchange access services by Decision 60236, in Docket No. U-2432-96-501 on June 12, 1997. The authorization for provision of local exchange services was on both a resell and facilities basis.

2. Sprint has not yet commenced the provision of such services in Arizona but has recently submitted a tariff for the provision of local exchange services to business customers on a resold basis that is proposed to be effective April 15, 1999. Sprint anticipates offering local exchange services and exchange access on a facilities basis during the next eighteen months and plans to eventually offer services to residential customers. Specific timetables are proprietary and subject to change.
