PROCEDURAL ORDER

BY THE COMMISSION:

On March 30, 2004, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order to Cease and Desist ("T.O.") and a Notice of Opportunity for Hearing ("Notice") against H. Jon Kunowski, Precision Model & Design ("PMD"), Air Lase, Inc. ("ALI") and American Innovative Research, Inc. ("AIR") (collectively the "Respondents") in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of stock.

Respondent, Kunowski was duly served with a copy of the T.O. and the Notice.

On April 23, 2004, Respondent Kunowski filed a request for a hearing.

On April 28, 2004, by Procedural Order, a pre-hearing conference was scheduled for May 20, 2004.

On May 20, 2004, the Division filed a Motion to Continue ("Motion") the pre-hearing and indicated that it had contacted Respondent Kunowski concerning the Motion, and he did not oppose the Division's request.

1 On May 21, 2004, by Procedural Order, the proceeding was continued to June 2, 2004.


2 On May 26, 2004, the Division filed a Motion to Stay ("Motion") the administrative
3 proceeding and requested that the pre-hearing conference be vacated because the Division had filed a
4 parallel proceeding in the Maricopa County Superior Court against the above-named Respondents
5 seeking permanent injunctive relief and sanctions against the Respondents for contempt of the
6 Commission's T.O.

7 Accordingly, the Division's Motion should be granted, the administrative proceeding stayed
8 and the pre-hearing conference vacated.

9 IT IS THEREFORE ORDERED that the Division's Motion is granted, and the proceeding
10 herein stayed.

11 IT IS FURTHER ORDERED that the pre-hearing conference on June 2, 2004 is hereby
12 vacated.


