PROCEDURAL ORDER

BY THE COMMISSION:

On March 23, 2004, Beaver Dam Water Company ("BDWC"), filed with the Arizona Corporation Commission ("Commission") an application for deletion of a portion of its Certificate of Convenience and Necessity ("Certificate") in Mohave County, Arizona.

On March 23, 2004, Sunrise Utilities, L.L.C. ("Sunrise") filed an application with the Commission for a Certificate to provide water and wastewater service to an area which includes BDWC's requested deletion area and other portions of Mohave County, Arizona.

Pursuant to A.A.C. R14-3-109, the Commission now issues this Procedural Order to consolidate these proceedings since the issues are related and the rights of the parties will not be prejudiced by this procedure.

IT IS THEREFORE ORDERED that the above-captioned proceedings shall be consolidated for purposes of hearing.


