Pat Stevens,

This is a response to your complaint to ACC.

I'm sorry if this offends you, but I had to respond to your complaint last, as it contains so many false statements (lies), that I must address them one at a time.

Item#1: "Turns off water one or more times every two weeks without notice."

First of all I don't just turn water off! If there is a break it is most difficult to give notice, and are handled in a timely manner. In recent discussions with neighbors, on your street, and in your unit, they can remember service interruption once or twice in the last year.
