Sun Health Corporation, by and through their undersigned counsel, file this motion to intervene pursuant to A.A.C. R14-3-3-105.


Sun Health is a non profit Arizona Corporation with tax exempt status under Section 501(c)(3) of the Internal Revenue Code. In Sun City, it operates the Walter O. Boswell Memorial Hospital along with a variety of ancillary health facilities. It also operates the Sun Health Care Center and the Del E. Webb Memorial Hospital in Sun City West. These facilities provide more than 600 patient beds and significant outpatient services.

Sun Health seeks intervention because increases in the price of water and sewer services will impact its ability to provide healthcare services to the residents of Sun City, Sun City West and the adjoining communities. Sun Health seeks intervention at this time because of concerns about the rate design proposed by Staff to the Arizona Corporation Commission.

1 The issues Sun Health wishes to address will not unduly broaden the issues currently
2 before the Commission.
