**BY THE COMMISSION:**

On July 1, 2003, Qwest Corporation ("Qwest") filed the Qwest Renewed Price Regulation Plan in accordance with the provisions of the Second Revised Settlement Agreement approved on March 30, 2001.

By Procedural Order dated November 17, 2003, the Commission determined that Phase I of the Access Charge Docket, which addresses Qwest's access charges, should be considered in conjunction with the Price Cap Plan Docket.

On August 12, 2004, the Arizona Local Exchange Carriers Association ("ALECA") filed an Application to Intervene in the above-captioned matters. ALECA is a trade association which includes the following regulated Arizona public service corporations: Arizona Telephone Company, CenturyTel, Copper Valley Telephone, Frontier Communications, Midvale Telephone Exchange, Navajo Communications, South Central Communications, Southwestern Telephone Company, Table Top Telephone Company and Valley Telephone Cooperative.

No party objected to the Application.


