PROCEDURAL ORDER

BY THE COMMISSION:

On July 23, 2004, Arizona Electric Power Cooperative, Inc. ("AEPCO") and Southwest Transmission Cooperative, Inc. ("SWTC") filed Applications for General Rate Increases.

On August 27, 2004, Commission Utilities Division Staff ("Staff") notified AEPCO and SWTC that their Applications met the sufficiency requirements of A.A.C. R14-2-103. Staff classified both entities as a Class A utilities.

Counsel for AEPCO and SWTRC and Staff have requested a Procedural Conference prior to the Hearing Division issuing its Procedural Order setting the matters for hearing.

IT IS THEREFORE ORDERED that the Procedural Conference in the above-captioned matters shall commence on **September 9, 2004, at 10:30 a.m.**, or as soon thereafter as is practical (immediately following the pre-hearing conference in the Duncan Valley Electric Cooperative rate case Docket No. E-01703A-03-0904), at the Commission's offices, **Room 218, 400 West Congress, Tucson, Arizona 85701**. 
