

PUBLIC NOTICE NOTICE OF JOINT APPLICATION OF XO ARIZONA, INC., ALLEGIANCE TELECOM OF ARIZONA, INC. AND XO COMMUNICATIONS SERVICES, INC. FOR AN INTERNAL CORPORATE REORGANIZATION AND FOR XO COMMUNICATIONS SERVICES, INC. TO PROVIDE SERVICE TO THE EXISTING CUSTOMERS OF XO ARIZONA, INC. AND ALLEGIANCE TELECOM OF ARIZONA, INC. AND FOR ALLEGIANCE TELECOM OF ARIZONA TO DISCONTINUE PROVIDING SERVICE IN ARIZONA

XO Arizona, Inc. ("XO Arizona"), Allegiance Telecom of Arizona, Inc. ("ALGX Arizona") and XO Communications Services, Inc. ("XO Communications") (collectively "Applicants" or "XO Subsidiaries"), all subsidiaries of XO Communications, Inc. ("XO"), the ultimate parent corporation, have filed with the Arizona Corporation Commission ("Commission") a joint application for approval of a corporate reorganization whereby the existing operating subsidiaries of XO in Arizona will be merged into a single operating subsidiary, XO Communications, and upon consummation of this reorganization, XO Communications will provide telecommunications services to the existing customers of XO Arizona and ALGX Arizona. Applicants have proposed in their joint application that XO Arizona's intrastate customer base, tariff and certificate of authority to provide telecommunications services in Arizona be transferred to its affiliate, XO Communications. XO end users will continue to receive service at substantially similar rates, terms and conditions and will continue to see the "XO" name on their bills. Similarly, ALGX Arizona's intrastate customer base will be transferred to XO Communications. ALLEGIANCE TELECOM OF ARIZONA will discontinue service to customers in Arizona. Applicants intend to grandfather ALGX Arizona's existing tariff, amended with the new name XO Communications, so that existing ALGX Arizona end users who choose to be served by XO Communications will continue to receive the same services at the same rates, terms and conditions as at present. All ALGX Arizona Customers have been notified of the XO acquisition by letter dated June 23, 2004.

Commission Rule A.A.C. R14-2-1107(B) provides that interested persons have thirty (30) days from the publication date of this notice to file objections to the joint application, to request a hearing and/or to submit a motion to intervene in the proceeding. However, failure to intervene will not preclude any interested person or entity from making a statement for the record.
