RE: STATUS REPORT IN THE MATTER OF THE APPLICATION OF DIAL-AROUND TELECOM, INC. FOR A CERTIFICATE OF CONVENIENCE AND NECESSITY TO PROVIDE FACILITIES-BASED INTEREXCHANGE TELECOMMUNICATIONS SERVICES IN THE STATE OF ARIZONA (DOCKET NO. T-04240A-04-0115)

On February 18, 2004, Dial-Around Telecom, Inc. ("Dial-Around") filed an application to obtain a Certificate of Convenience and Necessity ("CC&N") to provide facilities-based interexchange telecommunications services in Arizona. Arizona Corporation Commission Staff ("Staff") sent Dial-Around a Data Request via certified mail on February 27, 2004. The Data Request indicated the items in the application that were not sufficient and explained that a failure to respond would result in Staff recommending termination of Dial-Around's application to provide facilities-based interexchange service as per R14-2-1103(B)3 and R14-2-510(E)3.

On August 23, 2004, the Hearing Division of the Arizona Corporation Commission ("Hearing") issued a procedural order which ordered Staff to file a Status Report which sets forth its recommendation with regard to the action to be taken on Dial-Around's application.

Prior to Hearing's August 23, 2004 Procedural Order, Staff had several telephone conversations with Dial-Around. In these conversations, Dial-Around explained that it was having difficulties obtaining a Certificate of Good Standing in Arizona and was in the process of obtaining the most up to date financial information.

On August 26, 2004, in response to Hearing's Procedural Order, Dial-Around formally responded to Staff's February 27, 2004 Data Request. Dial-Around's response included answers

to all of Staff's questions except No. 2 which requested a copy of Dial-Around's Certificate of Good Standing in Arizona.

Because Dial-Around has been in contact with Staff and provided a response to Staff's First Set of Data Requests, Staff recommends Docket Number T-04240A-04-0115 remain open.
