INSUFFICIENCY LETTER

Dear Mr. Sallquist,

In reference to the Sunrise Utilities, L.L.C. Application for a Certificate of Convenience and Necessity, docketed August 17, 2004, this letter is to inform you that the application has not met the sufficiency requirements as outlined in Arizona Administrative Code.

On September 9, 2004, Staff provided Sunrise Utilities, L.L.C. with its first set of data requests. Consistent with the data requests and to ensure a complete application, please provide the following information.

1. Please provide a copy of the arsenic removal plan, including its design and costs.
2. Please provide clarification on the projected customers, including classification and projected demand.
3. Please provide clarification to Schedule 3 to ensure the proposed water plant in service is properly reflected.
4. Please provide clarification to Schedule 3 to ensure the proposed wastewater plant in service is properly reflected.
5. Please prepare a Curtailment Tariff.
6. Please provide clarification as to the wastewater rate design for commercial and residential services.


Please understand that according to A.A.C. R14-2-411 C.3, Staff may terminate an application if the applicant does not remedy all deficiencies within 60 calendar days of the notice of deficiency.

Page 2

Per Arizona Administrative Code upon meeting sufficiency requirements, the Commission has 150 calendar days for its substantive review. This includes conducting a hearing and preparing a proposed Opinion and Order to present to the Commission at an Open Meeting.
