**STAFF RESPONSE TO BEAVER
DAM WATER COMPANY'S
MOTION REGARDING
CONSOLIDATION**

On June 15, 2004, Beaver Dam Water Company ("Company" or "Beaver Dam") filed a financing application, W-03067A-04-0444, requesting a loan from WIFA for \$170,703. This WIFA loan was to supplement a line extension project totaling \$410,998 with a financing breakdown as follows:

WIFA loan	\$170,703
Walott Corp (within requested CC&N extension)	\$ 72,000
Feen-Robbins (within Littlefield certificate)	\$135,360
Reber/Beaver Dam (within Littlefield certificate)	<u>\$ 32,935</u>

Total project: \$410,998

1 On June 15th, 2004, the Company also filed a CC&N extension application, W-03067A-04-
2 0445, requesting to extend its CC&N in two different areas that are served by different Beaver Dam
3 water systems. The application also included an agreement to purchase Littlefield Water Company.
4

5 On July 15, 2004, Staff docketed a letter informing the Company that the CC&N extension
6 application, 04-0445, was sufficient.

7 On September 9th, 2004, the Company filed on behalf of Littlefield Water Company
8 ("Littlefield") a Sale of Assets and Transfer of CC&N application for Littlefield, W02298-04-0652.
9 The Company was assigned Docket No. W-03067A-04-0652 for this sale/transfer proceeding. (The
10 purchase agreement that was filed in the CC&N extension application can be used for the
11 sale/transfer application.)

13 On September 9th, 2004, the Company also filed a letter requesting to consolidate the
14 financing (04-0444) and the CC&N extension (04-0445) applications. The Company also requested
15 to amend its CC&N extension application (04-0445) to include an additional 2-1/2 square-miles
16 (approximate) of requested area.

17 Staff believes that the Company's applications, W-03067A-04-0444 (financing), W-03067A-
18 04-0445 (CC&N extension), W-03067A-04-0652 (sale/transfer of Littlefield) and Littlefield's
19 application, W-02298A-04-0652 (sale/transfer to Company) are sufficient enough to proceed and all
20 four docket numbers be consolidated.
