**NOTIFICATION OF
INTERVENTION**

BY THE COMMISSION:

8 On November 22, and December 13, 2002, Arizona-American Water Company, Inc.
9 (“Applicant”) filed with the Arizona Corporation Commission (“Commission”) applications in the
10 above-captioned dockets for rate increases in the Applicant’s water and wastewater districts.

11 On October 3, 2003, Sun Health Corporation filed a Motion to Intervene in the above-
12 captioned matters, stating that it operates facilities located in Sun City and Sun City West, and that it
13 seeks intervention because of concerns about the rate design proposed by the Commission’s Utilities
14 Division Staff.

15 On October 14, 2003, Applicant filed a response, stating that it does not object to intervention
16 by Sun Health Corporation provided that (1) intervention is limited in accordance with the Procedural
17 Order issued March 14, 2003, i.e., Sun Health’s participation is limited to the dockets pertaining to
18 Sun City and Sun City West and to only those issues in which Sun Health has a direct and substantial
19 interest, and (2) the deadlines for filing written testimony, the hearing dates and other procedural
20 deadlines and requirements will not be altered or delayed by reason of such intervention.

21 No other parties responded to the Motion to Intervene.

22 IT IS THEREFORE ORDERED that Sun Health Corporation is hereby granted intervention
23 in the above-captioned matters.


