PROCEDURAL ORDER

**BY THE COMMISSION:**

By Procedural Order dated October 10, 2003, Cox Arizona Telcom, LLC, ("Cox") was ordered to file comments on whether the FCC's Triennial Review Order resolved the concerns Cox had raised about Qwest Corporation's Cable, Wire and Service Termination Policy tariff. Interested Parties were ordered to file Responsive comments and Staff was ordered to summarize the comments and make recommendations concerning further proceedings.

Cox, Qwest and AT&T filed comments. On January 12, 2004, Staff filed a Staff Report and recommended that a Notice of Inquiry be commenced.

Accordingly, a procedural conference for the purpose of determining further action by the Commission on this matter should be set.

IT IS THEREFORE ORDERED that a Procedural Conference to discuss the recommendations in the above-captioned matter shall commence on March 8, 2004 at 10:00 a.m., or as soon thereafter as is practicable following the procedural conferences set in the TRO and Qwest Price Cap Plan dockets, at the Commission's offices, 1200 West Washington, Phoenix, Arizona.<sup>1</sup>


