STAFF'S MOTION FOR EXTENSION OF TIME

The Arizona Corporation Commission Staff ("Staff") hereby respectfully submits this Motion to extend the time to file its Staff Report. At its November 16, 2001 Open Meeting to consider the Emerging Services Recommended Order, the Commission discussed what the policy should be relative to the location of the demarcation point between Qwest's and other telecommunications carriers' networks and the facilities controlled by the premises owner. The Commission determined that it should address the issue in the context of a proceeding that would apply to all telecommunications companies and not just Qwest. The Commission instructed Staff to open a docket to address this issue. Staff requested a generic docket be opened, and filed a Request for Procedural Order in order to obtain information from interested parties on a number of issues necessary to its determination of the proper policy for location of the demarcation point.

By Procedural Order dated May 29, 2002, Administrative Law Judge Rodda ordered that interested parties file Initial Comments addressing Staff's issues on or before July 24, 2002 with Reply Comments to be filed on or before August 21, 2002. Finally, the Order required Staff to file a Report with the Commission on or before September 18, 2002. By Procedural Order dated July 29, 2002, Cox Arizona Telecom's Motion to Continue Filing Dates was granted and the ALJ ordered Initial Comments to be filed on or before August 30, 2002, Reply Comments on or before September 27, 2002, and Staff's Report on or before October 25, 2002. By Procedural Order dated September

1 23, 2002, AT&T Communications of the Mountain States, Inc. and TCG Phoenix (collectively
2 "AT&T") were granted an extension of the remaining procedural schedule. It was ordered that Reply
3 Comments were to be filed by October 30, 2002, and the Staff Report to be filed by November 29,
4 2002.

6 Staff requires additional time to consider the filed Comments and Replies of the Parties and to
7 make its recommendations. Staff, therefore, requests an extension of time to January 31, 2003 to file
8 its Staff Report and recommendations.
