20 Pursuant to A.A.C. R14-3-105, Mohave Electric Cooperative, Inc. ("Mohave") hereby
 21 moves the Arizona Corporation Commission ("Commission") for an order granting Mohave leave to
 22 intervene in the above-captioned proceedings.

II.

24 Mohave Currently serves nearly thirty thousand (30,000) members in Mohave, Yavapai and
 25 parts of Coconino Counties since 1946 pursuant to a Certificate of Convenience and Necessity

1 ("CC&N") granted by the Commission. The Arizona Electric Power Cooperative is a partial
2 requirements wholesale supplier of electricity for Mohave; Southwest Transmission Cooperative is a
3 partial requirements transmission supplier to Mohave. Therefore, Mohave will be directly and
4 substantially affected by the proceedings.

6 The granting of intervenor status to Mohave will not delay or unduly broaden the
7 issues presented in the proceedings.


