PROCEDURAL ORDER

16 **BY THE COMMISSION:**

17 On March 30, 2001, the Arizona Corporation Commission ("Commission") issued Decision  
18 No. 63536. In Decision No. 63536, the Commission granted Lotel, d/b/a Coordinated Billing  
19 Service ("CBS") authority to provide resold interexchange telecommunications services. The  
20 certificate was conditioned on the Company filing the date when they will begin providing service to  
21 Arizona customers within 30 days of the date of the Decision.

22 On June 21, 2001, CBS filed a request for an extension. Staff has no objections.

23 IT IS THEREFORE ORDERED that Lotel, Inc. d/b/a Coordinated Billing Service's request  
24 for extension is granted and Lotel, d/b/a Coordinated Billing Service shall notify the Commission at  
25 least 30 days prior to providing service to Arizona customers.


