PROCEDURAL ORDER

BY THE COMMISSION:

By Procedural Order dated July 23, 2004, the Arizona Corporation Commission ("Commission") set a schedule for filing briefs and for oral argument in this matter.

On September 17, 2004, counsel for Eschelon Telecom of Arizona, Inc. ("Eschelon") and Commission Utilities Division Staff ("Staff") requested a procedural conference. During a teleconference on the same date, with both parties represented, counsel for the parties reported that Eschelon had submitted a settlement proposal to Staff based on a recent settlement with the Washington Public Utilities Commission. The parties requested a suspension of the briefing schedule while Staff reviewed the proposal.

The parties' request is reasonable.

IT IS THEREFORE ORDERED that the briefing schedule established in the July 23, 2004 Procedural Order is suspended, and the oral argument set for October 29, 2004, is vacated, pending future notice.

IT IS FURTHER ORDERED that a telephonic Procedural Conference for the purpose of updating the status of settlement negotiations shall commence October 14, 2004 at 10:30 a.m. at the Commission's Tucson offices, 400 West Congress, Tucson, Arizona. 
