PROCEDURAL ORDER

9 **BY THE COMMISSION:**

10 On June 8, 2004, DIECA Communications, Inc., dba Covad Communications Company  
11 ("Covad") filed with the Arizona Corporation Commission ("Commission") a Petition for Arbitration  
12 ("Petition") of a proposed interconnection agreement with Qwest Corporation ("Qwest") pursuant to  
13 A.A.C. R14-2-1505 and Section 252(b) of the Communications Act of 1934, as amended by the  
14 Telecommunications Act of 1996 ("the Act").

15 On July 26, 2004, Covad filed a Request for Procedural Conference. Covad's Motion stated  
16 that counsel for Qwest agrees that a procedural conference would be appropriate to discuss the timing  
17 and conduct of this arbitration proceeding.

18 By Procedural Order issued July 29, 2004, a procedural conference was scheduled for August  
19 6, 2004. Due to a scheduling conflict, the procedural conference will be rescheduled.

20 IT IS THEREFORE ORDERED that the Procedural Conference previously rescheduled for  
21 August 6, 2004 shall be rescheduled for **August 9, 2004 at 10:00 a.m.**, at the offices of the  
22 Commission, 1200 West Washington, Phoenix, Arizona 85007. Parties may participate


