PROCEDURAL ORDER

BY THE COMMISSION:

On July 1, 2003, Qwest Corporation ("Qwest") filed the Qwest Renewed Price Regulation Plan pursuant to the provisions of the Second Revised Settlement Agreement approved in Decision No. 63487 on March 30, 2001.

By Procedural Order dated November 17, 2003, the Commission determined that Phase I of the Access Charge Docket, which addresses Qwest's access charges, should be considered in conjunction with the Price Cap Plan Docket.

By Procedural Order dated July 1, 2004, the Commission set the matter for hearing and established the timing and form of notice. The July 1, 2004, Procedural Order directed Qwest to mail notice of the hearing to its customers by August 15, 2004.

On July 23, 2004, Qwest filed a Motion for Extension of Time to Publish Notice of Open Meeting. Qwest states that it received the July 1, 2004 Procedural Order to late to have it included in its July billing cycle. Qwest requests that the deadline for mailing be extended until September 1, 2004.

No party opposed the extension. Requiring Qwest to mail the notice separately from its bills would be very costly. Customers will not be prejudiced by the extension. The request is reasonable and should be granted

1 IT IS THEREFORE ORDERED that the deadline established in the July 1, 2004 Procedural
2 Order for Qwest to mail notice of the hearing to its customers shall be extended until September 1,
3 2004.

4 IT IS FURTHER ORDERED that all other provisions of the July 1, 2004 Procedural Order
5 shall remain in effect.

6 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
7 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
