REQUEST FOR SUSPENSION OF
30-DAY TIME CLOCK

Qwest Corporation ("Qwest") respectfully requests that the Arizona Corporation Commission (the "Commission") suspend the thirty day time clock in A.A.C. R14-2-1508, with respect to the QPP Master Service Agreement.

On August 6, 2004, Qwest filed its Motion to Dismiss that part of MCI's application seeking Arizona Corporation Commission ("Commission") review and approval of the QPP Master Service Agreement (the "Commercial Agreement")¹ by which Qwest agreed to provide Qwest Platform Plus™ services to MCI. In its application, MCI requests Commission approval for both a "negotiated amendment" to an existing interconnection agreement between MCI and Qwest and the Commercial


¹ The MCI application filed on July 26, 2004 seeks Commission review and approval of two discrete contracts. One is an Amendment to Interconnection Agreement for Elimination of UNE-P and Implementation of Batch Hot Cut Process and Discounts (the "ICA Amendment"). The other is the Commercial Agreement. Qwest's Motion to Dismiss is only made with respect to the Commercial Agreement. The Commercial Agreement consists of the Qwest Master Services Agreement, Services Exhibit 1 – Qwest Platform Plus™ Service, Attachment A of Service Exhibit 1 (Performance Targets for Qwest QPP™ Service and the Rate Sheet.

1 Agreement without citation to any Commission rule. It is therefore unclear whether MCI
2 is seeking review of the Commercial Agreement pursuant to A.A.C. R14-2-1508 (which
3 addresses the filing of amendments to interconnection agreement), or some other rule.
4 A.A.C. R14-2-1508 provides that if the proposed amendment is not rejected by the
5 Commission within 30 days of its filing, such amendment will automatically become
6 effective. Accordingly, Qwest requests the suspension of the 30-day time clock
7 established in A.A.C. R14-2-1508 (if applicable) so that the Commission may have
8 sufficient time to consider Qwest's Motion to Dismiss.
