PROCEDURAL ORDER

BY THE COMMISSION:

On July 1, 2003, Qwest Corporation ("Qwest") filed the Qwest Renewed Price Regulation Plan in accordance with the provisions of the Second Revised Settlement Agreement approved on March 30, 2001.

By Procedural Order dated November 17, 2003, the Commission determined that Phase I of the Access Charge Docket, which addresses Qwest's access charges, should be considered in conjunction with the Price Cap Plan Docket.

On July 26, 2004, Xspedius Management Co. Switched Services, LLC and Xspedius Management Co. of Pima County LLC (collectively "Xspedius") filed an Application to Intervene in the above-captioned matters.

No party objected to the Application.

IT IS THEREFORE ORDERED that Xspedius' Application To Intervene is granted.


