PROCEDURAL ORDER

BY THE COMMISSION:

On March 26, 2004, WWC License LLC dba CellularOne ("Western Wireless") filed with the Arizona Corporation Commission ("Commission") the above-captioned application.

On August 17, 2004, Western Wireless filed a Request for Procedural Conference to address the timing and conduct of the proceeding in this docket ("Request"). The Request stated that the Commission's Utilities Division Staff agrees with Western Wireless that a procedural conference would be appropriate. 
