On March 26, 2004, WWC License LLC dba CellularOne ("Western Wireless") filed with the Arizona Corporation Commission ("Commission") the above-captioned application.

On August 17, 2004, Western Wireless filed a Request for Procedural Conference to address the timing and conduct of the proceeding in this docket ("Request").

By Procedural Order issued August 23, 2004, a procedural conference was set to commence on September, 2004 at 10:00 a.m.

On August 24, 2004, the Commission's Utilities Division Staff ("Staff") filed a Motion to Reschedule Procedural Conference ("Motion"). The Motion stated that the time set for the procedural conference is also the time set for a workshop concerning the Commission's draft Consumer Proprietary Network Information ("CPNI") rules in Docket No. RT-00000J-02-0066, that some of the attorneys and Staff members assigned to the CPNI case are also assigned to this case, and that counsel for Western Wireless is also planning to attend the CPNI workshop.


