In your letter of March 3, 2004, you asked three questions. The following is the answer to each of your questions:

1. What is the immediate health risk to people in that area?

The health risk is to infants that are 6-months or less of age. Drinking water with high nitrates can cause persons in this age group to become seriously ill and, if untreated, even die. Arizona American Water Company ("Company") has notified its customers of this problem through the attached Public Notice (see Tab 1).

2. If there is a public health concern with the water in Desert Hills, what must be done to immediately remedy the situation?

There is a public health concern. Therefore, the Company has provided the required public notice to its customers and is also making bottled water available. Per Arizona Department of Environmental Quality ("ADEQ") requirements the Company is only required to provide bottled water to the at risk group of customers (i.e., infants 6-months of age or younger). However, the Company will make bottled water available to anyone that has a concern and not just to the at risk group.

In addition, the Company is in the process of obtaining a new source of water. Most likely this source will be a new well with low nitrate water which it will be able to blend with its existing well in order to deliver water that meets the nitrate requirements. This new well will take some time to complete (permitting and construction time could take several months).

In speaking with ADEQ personnel, this matter is being forwarded to its Enforcement Unit, not necessarily of any enforcement action, but just as a matter of course. At the present time the Company is complying with everything that ADEQ is requiring.

3. Has this matter been addressed in the rate case?

This matter had not developed by the time Staff had filed its testimony in the current rate case. At the time Staff's testimony had been filed, the latest ADEQ report stated that the system was delivering water that met all required quality standards.

1. The Company's customer notice,
2. The Company's radio spots language,
3. The original ADEQ report used by Staff in its testimony (dated 1-8-03), and
4. The latest ADEQ report (dated 3-4-04)

Please let me know if this does not answer all your questions sufficiently.

Concern lingers over Desert Hills water

The chief of the Desert Hills Fire Department is concerned Arizona American Water Company has not given proper notification to customers whose drinking water contains high levels of nitrates.

"As far as I know the water is still unsafe to drink," said Chief Mat Espinoza. "I don't think Arizona American took this very seriously, but there are certain people it will still affect. I don't feel Arizona American has met their obligation to notify people."

On Feb. 19, Kevin Tilden, spokesman for Arizona American Water, said the company would be sending inserts with customers' next billing statements updating them on the situation. However, Espinoza said he didn't receive an insert in the fire department's water bill.

The bill, which charges for water usage though Feb. 26, makes no mention of nitrate levels. In addition, it states: "Arizona-American takes great pride in the water we deliver to you. Our water meets or exceeds all standards."

Tilden said Tuesday that the bill inserts would begin with the billing cycle that started Monday. He added that small children still should not drink the water, however, he said it isn't dangerous for adults.

Espinoza said another reason he is not happy because the company is seeking a rate increase through the Arizona Corporation Commission. "Should they be able to raise their rates if they are not putting out a good product?" he asked.

Tilden said routine testing on Feb. 13 showed levels of 12 milligrams per liter, slightly exceeding the nitrate standard of 10 mg/L.

Infants under six months are at risk of suffering Blue Baby Syndrome, an affliction caused by consuming excess nitrates.

Tilden said the company is going to connect two wells via pipeline, mixing the contaminated water with safe water. He said the mixture should be well under maximum levels set by the Environmental Protection Agency. However, Tilden said it could take up to six months to complete the connection, including all of the required permitting.

Arizona American is scheduled to meet with the Desert Hills Homeowner Association in April.

According to the company, boiling, freezing or filtering the water should not reduce nitrate levels. However, it said "well maintained" reverse osmosis systems should remove most of the nitrates.

Patrick Gibbons, spokesman for ADEQ, said high nitrate levels are typically caused by septic system discharge. In 1997, a similar situation in Lake Havasu City was attributed to septic tanks.

Arizona American said it has limited bottled water available to customers. Customers with questions or concerns can call Arizona American Water at (800) 383-0834.

**Do not give the water to infants under 6 months old, or use it to make
infant formula**

(Desert Hills, AZ – Feb. 13, 2004) – Arizona American Water, in compliance with United States Environmental Protection Agency and the Arizona Department of Environmental Quality regulations, regularly samples source and treated water in its water system. In a recent routine sampling, water sample results received on February 13, 2004, showed that nitrates levels in the area were 12 mg/l. This is above the nitrate standard or maximum contaminant level (MCL) of 10 mg/l. Nitrates in drinking water are a serious concern for infants less than six months old.

Desert Hills area customers of Arizona American Water should not give water to infants. Infants below the age of six months who drink water containing nitrates in excess of the MCL could become seriously ill and, if untreated, may die. Symptoms include shortness of breath and blue baby syndrome. Blue baby syndrome is indicated by blueness of the skin. Symptoms in infants can develop rapidly with health deteriorating over a period of days. If symptoms occur, seek medical attention immediately.

Tap water should not be used to prepare juice from concentrate or infant formula. Bottled or other water low in nitrates should be used until further notice. Boiling, freezing, filtering or letting the water stand will not reduce the nitrate level. Well maintained reverse osmosis systems should remove most of the nitrates in tap water. Adults and children more than six months old process nitrates differently than infants less than six months old and may use the water. If you are pregnant or have specific health concerns, please contact your doctor.

Nitrates in drinking water can come from natural, industrial or agricultural sources, including septic systems. In 1997, ADEQ believed septic system discharge to be the largest contributor to groundwater quality deterioration when elevated nitrogen levels were found in wells throughout the City of Lake Havasu. Levels can vary throughout the year, and it is not now known when levels may reduce to be below the MCL. When nitrates are reduced customers will be notified. If nitrates continue to be high customers will be notified at least every three months.

Proposed 30-second radio announcement:

Desert Hills area customer of Arizona American Water should take note. Recent water tests have revealed 12 milligrams per liter of nitrates. The national standard is 10 milligrams per liter. Infants less than six months who drink water containing nitrate in excess of the MCL could become seriously ill and, if untreated may die. Symptoms include shortness of breath and blue baby syndrome, and Tap water should not be used for mixing infant formula or juices. Nitrates in drinking water can come from a number of sources, including septic tanks. Only infants less than six months old are affected by this notice. About Nitrates in Your Water

At Arizona American Water, water quality is our number one commitment. We constantly monitor water quality, conducting hundreds of tests each year to measure and maintain the quality of the water we send to your home. Arizona American Water regularly samples the water quality in your water system. We do this to make sure your water meets or exceeds U.S. Environmental Protection Agency and Arizona Department of Environmental Quality (ADEQ) regulations. Each year, we do a comprehensive report of our test results, called the Annual Water Quality Report or Consumer Confidence Report. Look for this report in your mailbox in early June.

In a recent routine sampling on February 13, 2004, water sample results showed that nitrate levels in the area were 12 mg/l, which exceed the maximum nitrate standard of 10 mg/l. Although this is only two parts per million over the standard, high nitrates can be dangerous to infants. Nitrates in drinking water are a serious concern for infants less than six months old. Because of the possible danger, we immediately notified the public through radio and newspaper announcements. As a result of this exceedance, you should not give tap water to infants under six months, or use it to make infant formula.

The cause for excess nitrate levels

Nitrates in drinking water can come from natural, industrial or agricultural sources, including septic systems. In 1997, ADEQ believed septic system discharge to be the largest contributor to groundwater quality deterioration when elevated nitrogen levels were found in wells throughout the City of Lake Havasu. Levels can vary throughout the year, and it is not now known when nitrates may reduce to levels safe for infants.

How we are correcting this problem for the future

Nitrates in low concentration are not a problem for anyone, including infants. To prevent future nitrate levels that exceed safe standards, Arizona American Water will be building a new pipeline to dilute water from the problem wells by blending it with water from a well with extremely low nitrate levels. This will ensure a reliable future supply and should prevent future unacceptable nitrate concentrations.

When you will know this problem is solved

When nitrates are fully reduced, customers will be notified. If nitrates continue to be high, customers will be notified at least every three months.

High nitrate levels only impact infants

Desert Hills area Arizona American Water customers should not give water to infants below the age of six months. Infants below the age of six months who drink water containing nitrates in excess of standards could become seriously ill and, if untreated, may die. Symptoms include shortness of breath and blue baby syndrome. Blue baby syndrome is indicated by blueness of the skin. Symptoms in infants can develop rapidly with health deteriorating over a period of days. If symptoms occur, seek medical attention immediately. Adults and children older than six months process nitrates differently than infants and may not be affected.

Tap water should not be used to prepare juice from concentrate for infants or infant formula. Bottled or other water low in nitrates should be used until further notice. Bottled water will be made available by contacting 928-763-0486. Boiling, freezing, filtering or letting the water stand will NOT reduce the nitrate level. Well-maintained reverse osmosis systems should remove most of the nitrates in tap water. Adults and children more than six months old process nitrates differently than infants less than six months old and may not be affected by high nitrates.
