

Final Workshop to Resolve Outstanding Issues



To allow parties additional time to resolve outstanding issues relating to Checklist Items 7, 10, 3 and 13, the Arizona Corporation Commission ("ACC" or "Commission") Staff has scheduled a final Workshop on March 7, 2000 to discuss any further progress made by the parties on these issues and to make one last effort to resolve them at the Workshop. Commission Staff specifically requests that all parties make a good faith effort to have their technical experts available for the Workshop. A location for the Workshop has not yet been determined. The Commission Staff will notify parties of the location for the Workshop sometime next week and will also distribute an agenda at that time.

Parties shall have an opportunity to file additional written comment on outstanding issues prior to the Workshop on March 7, 2000. Comments by the CLECs will be due by close of business on Tuesday, February 29, 2000. U S WEST's reply comments will be due by close of business on Friday, March 3, 2000. The Commission Staff will also have a conference bridge available so that people unable to attend in person can participate telephonically.
