PROCEDURAL ORDER

BY THE COMMISSION:

On May 1, 2003, Pine Water Company filed with the Arizona Corporation Commission ("Commission") an application for a determination of the current fair value of its utility plant and property, a rate increase and for approval of long-term debt.

By Procedural Order issued January 2, 2004, the hearing in this matter was rescheduled to begin March 3, 2004.

On February 27, 2004, a procedural teleconference was conducted with all parties to discuss rescheduling the evidentiary hearing in this matter. Pursuant to that discussion, all parties agreed to reschedule the hearing to begin on March 9, 2004, at 1:30 p.m.

The current hearing date of March 3, 2004, at 9:00 a.m., will be used for public comment, if necessary.

IT IS FURTHER ORDERED that the current hearing date of March 3, 2004, at 9:00 a.m., will be used for public comment, if necessary.


