PROCEDURAL ORDER

BY THE COMMISSION:

On May 1, 2003, Pine Water Company ("Applicant" or "Company") filed with the Arizona Corporation Commission ("Commission") an application for a determination of the current fair value of its utility plant and property, a rate increase and for approval of long-term debt.

By Procedural Order issued October 24, 2003, the hearing in this matter was rescheduled for January 15, 2004, and various other filing dates were established. However, the previously scheduled December 1, 2003 pre-hearing conference was not rescheduled.

IT IS THEREFORE ORDERED that the pre-hearing conference in this proceeding shall be rescheduled for January 12, 2004, at 1:30 p.m., at the offices of the Commission.
