STIPULATION

Applicant Pine Water Company, Inc. ("PWCo") and Arizona Corporation Commission Utilities Staff ("Staff") hereby jointly request an order modifying the previously scheduled deadlines in the above-captioned docket. The modified procedural schedule requested herein is necessary for two reasons. First, the Pine-Strawberry Water Improvement District ("District") has sought leave to intervene in this proceeding, and, in connection therewith, has requested an extension of the deadline to file direct testimony in this proceeding. Second, counsel for PWCo and Staff have a conflict on December 15, 2003, the date previously scheduled for the hearing in this matter as the result of another pending Commission proceeding. Therefore, and without admission as to the validity of the District's request for an extension of the deadline for filing direct testimony, PWCo and Staff believe that modification of the procedural schedule as set forth herein is necessary and appropriate.

The modified procedural schedule jointly sought by PWCo and Staff is as follows:


