On May 1, 2003, Pine Water Company ("Applicant") filed with the Arizona Corporation Commission an application for determination of the current fair value of its utility plant and property, a rate increase and for approval of long-term debt.

On June 10, 2003, a Rate Case Procedural Order was issued setting the application for hearing on December 15, 2003, and establishing associated procedural deadlines. There have been numerous requests from the Applicant's customers for a public comment session prior to the hearing.


