

PROCEDURAL ORDER

BY THE COMMISSION:

On July 7, 2000, Staff of the Arizona Corporation Commission ("Staff") filed a Motion to Extend Filing of Staff Report ("Motion") to August 8, 2000. According to Staff's Motion, Staff sent Data Requests to Arizona Water Company ("Arizona Water") which are due on July 10, 2000.

On July 6, 2000, Arizona Water requested that Staff give it an extension of time to answer the Data Requests until July 20, 2000. Staff stated that it did not oppose such an extension of time as long as Arizona Water agreed to allow Staff an extension in order to prepare the Staff Report. Staff also requests that Arizona Water and Casa Grande have until August 23, 2000 to file any response to the Staff Report.

Arizona Water does not oppose this request.

Based on the above, it is appropriate to grant Staff's Motion.

IT IS THEREFORE ORDERED that the Staff Report in this matter shall be filed on or before August 8, 2000.

IT IS FURTHER ORDERED that Arizona Water and Casa Grande shall have until August 23, 2000 to file any response to the Staff Report.


