**STAFF'S MOTION TO EXTEND
FILING OF STAFF REPORT**

On May 10, 2000, Arizona Water Company ("Arizona Water") filed an application for approval of Proposed Tariff No. TE-264.

On June 9, 2000, the Commission suspended the application for one-hundred twenty (120) days, through and including October 8, 2000 to allow Staff additional time to review the application.

On June 23, 2000, a Procedural Order was issued ordering Staff to file a Staff Report on or before July 25, 2000.

Further, on June 23, 2000, the City of Casa Grande was granted intervention in this case.

On June 30, 2000, Staff propounded Data Requests to Arizona Water. Responses to these data requests are essential for Staff in preparing the Staff Report for this matter.

Responses to these Data requests are due on or before July 10, 2000.

On July 6, 2000, Arizona Water requested that Staff give them an extension of time for answering the Data Requests until July 20, 2000. Staff informed Arizona Water that Staff would not be opposed to such an extension as long as Arizona Water agrees to allow Staff an extension in order to prepare the Staff Report. Arizona Water had no opposition to Staff requesting such an extension.

Staff hereby requests that an extension to file the Staff Report until August 8, 2000 to allow Staff an opportunity to receive and evaluate the Data Request responses due July 20, 2000.


