PROCEDURAL ORDER

**BY THE COMMISSION:**

On June 1, 2000, the City of Casa Grande ("Casa Grande") filed a Motion ("Motion") to Intervene in the Matter of the Filing by Arizona Water Company ("Arizona Water") of Proposed Tariff No. TE-264, Treated Effluent Service. On the same date, June 1, 2000, Casa Grande filed an Objection to Proposed Tariff.

On June 19, 2000, Arizona Water filed a Response to the City of Casa Grande's Motion to Intervene stating that Arizona Water does not oppose Casa Grande's Motion.

As no objections have been filed, Casa Grande shall be granted intervention in this matter.

In order to expedite this matter, it is appropriate to have Staff of the Arizona Corporation Commission ("Staff") prepare a Staff Report on this matter to be filed on or before July 25, 2000. Arizona Water and Casa Grande shall have until August 9, 2000 to respond to the Staff Report.

IT IS THEREFORE ORDERED that Casa Grande is hereby granted intervention in this matter.

IT IS FURTHER ORDERED that Staff shall prepare a Staff Report to be filed on or before July 25, 2000.

IT IS FURTHER ORDERED that Arizona Water and Casa Grande shall have until August 9, 2000 to file any response to the Staff Report.
