On November 5, 1999, AmeriVision Communications, Inc. (AmeriVision) filed tariff revisions to completely replace its existing tariff. FINDINGS OF FACT

1. AmeriVision Communications, Inc. (AmeriVision) is certificated to provide telecommunications services as a public service corporation in the State of Arizona.

2. On November 5, 1999, AmeriVision filed tariff revisions to completely replace its existing tariff:

AmeriVision Communications, Inc.

Arizona Tariff No. 3, Page No. 1, Original, through Page No. 26, Original

AmeriVision Communications, Inc.

Arizona Tariff No. 4, Page No. 1, Original, through Page No. 41, Original

3. AmeriVision indicates that the purpose of the filing to update rates, change the company address, and reformat the tariff to Y2K compatible WordPerfect 8. The filing also adds three new services, Outbound Long Distance, Inbound Toll Free and Travel Service and grandfather older services.

1           4.       Staff recommends that the filing be suspended because of the date of the filing,  
 2 Staff has not had sufficient time to review and analyze the data provided by AmeriVision.  
 3 Therefore, Staff respectfully requests that the Commission suspend this tariff filing for sixty (60)  
 4 days.

 6           1.       AmeriVision, is an Arizona public service corporation within the meaning of  
 7 Article XV, Section 2, of the Arizona Constitution.

8           2.       The Commission has jurisdiction over the AmeriVision and of the subject matter  
 9 in this Application.

10          3.       The Commission, having reviewed the tariff pages and Staff's Memorandum  
 11 dated November 10, 1999, concludes that it is in the public interest to suspend this filing for a  
 12 period of sixty (60) days.

 14           THEREFORE, IT IS ORDERED that the filing be and hereby is suspended until and  
 15 including February 2, 2000.

16           IT IS FURTHER ORDERED that this Order shall become effective immediately.
