PROCEDURAL ORDER

BY THE COMMISSION:

On March 10, 2000, Citizens Utilities Company ("Citizens") and Cap Rock Energy Corporation ("Cap Rock") filed with the Arizona Corporation Commission ("Commission") a joint application for approval of the sale of certain electric utility properties in Arizona and the transfer of the Certificate of Convenience and Necessity ("Certificate") from Citizens and its Arizona Electric Division to Cap Rock. Our May 22, 2000 Procedural Order set the matter for hearing commencing on September 6, 2000.

Subsequently, the parties requested a procedural conference for July 21, 2000. As a result, a procedural conference was held at 1:15 p.m. on July 21, 2000 at the Commission's offices in Phoenix, Arizona. Based on agreement by the parties, the procedural dates were modified.

IT IS THEREFORE ORDERED that Citizens and Cap Rock shall file any direct testimony and associated exhibits to be presented at hearing on or before 4:00 p.m. on August 14, 2000.

IT IS FURTHER ORDERED that Staff and Intervenors shall file any direct testimony and associated exhibits to be presented at hearing on or before 4:00 p.m. on September 21, 2000.

IT IS FURTHER ORDERED that Citizens and Cap Rock shall file any rebuttal testimony and associated exhibits to be presented at hearing on or before 4:00 p.m. on October 5, 2000.

IT IS FURTHER ORDERED that the 10:00 a.m. September 6, 2000 hearing date shall be retained as a public comment hearing.

1 IT IS FURTHER ORDERED that a hearing shall commence on October 17, 2000 at 10:00
2 a.m., or as soon thereafter as is practical, at the Commission's offices, 1200 West Washington Street,
3 Phoenix, Arizona 85007.

4 IT IS FURTHER ORDERED that a pre-hearing conference shall be held on October 12, 2000
5 at 1:30 p.m., at the Commission's offices in Phoenix, Arizona for the purpose of discussing the
6 scheduling of witnesses and the conduct of the hearing.

7 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
8 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
