PROCEDURAL ORDER

11 **BY THE COMMISSION:**

12 On March 10, 2000, Citizens Utilities Company, Inc. ("Citizens") and CAP Rock Energy
13 Corporation ("Cap Rock Energy") filed a Joint Application for the approval of the Sale of Certain
14 Electric Utility Properties in Arizona and the transfer of the Certificate of Convenience and Necessity
15 from Citizens and the Arizona Electric Division to Cap Rock Energy.

16 On March 24, 2000, the Residential Utility Consumer Office ("RUCO") filed an Application
17 to Intervene. On March 27, 2000, the Arizona Utility Investors Association, Inc. ("AUIA") also filed
18 an Application to Intervene.

19 There has been no opposition to the requests to intervene.

20 IT IS THEREFORE ORDERED that the requests to intervene by RUCO and AUIA are
21 hereby granted.
