**PROCEDURAL ORDER FOR

On March 10, 2001, Citizens Utilities Company ("CUC") and Cap Rock Energy Corporation ("Cap Rock") filed with the Arizona Corporation Commission ("Commission") a joint application for approval of the sale of certain electric utility properties in Arizona and the transfer of the Certificate of Convenience and Necessity ("CC&N") from Citizens to Cap Rock.

On March 12, 2001, Citizens and Cap Rock jointly filed a Notice of Dismissal, because the parties have terminated the purchase and sale agreement.

IT IS THEREFORE ORDERED that the matter is hereby dismissed and Docket Nos. E-01032A-00-0163, E-01032B-00-0163, E-01032C-00-0163 and E-03851A-00-0163 shall be administratively closed.


