13 this status report. On January 2, 2001, Cap Rock filed its S-1 statement with the Securities and
14 Exchange Commission in order to complete its conversion from a cooperative into an investor-
15 owned utility as part of this transaction. Cap Rock and Citizens continue to work on reaching a
16 modified transaction; however, in light of the extremely volatile power markets, Cap Rock and
17 Citizens have been devoting their attention to the resolution of these issues in light of the impacts
18 they may have on this transaction.


