

13 Pursuant to A.A.C. R14-3-105 and the Rate Case Procedural Order in this proceeding

14 dated March 4, 1999, OnePoint Communications-Colorado, LLC ("OnePoint Communications" or
15 the "Company") hereby petitions the Arizona Corporation Commission ("Commission") for an order
16 granting leave to intervene in the above-captioned U S WEST Communications, Inc. ("U S WEST")
rate case proceeding. This Application is based upon the following:

17 1. OnePoint Communications has applications pending before this Commission
18 to provide competitive resold and facilities-based local and long distance telecommunications services
19 within the State of Arizona, and the Company is providing telecommunications services to customers
20 at the present time. OnePoint Communications resells the telecommunications services of U S WEST,
21 and the Company will interconnect with U S WEST when it commences facilities-based service.
22 Thus, OnePoint Communications is directly and substantially affected by the outcome of the U S
23 WEST rate case proceeding.

24 2. OnePoint Communications' participation in the U S WEST rate case proceeding
25 will not unduly broaden the issues presented.


