Pursuant to A.A.C. R14-3-105 and the Rate Case Procedural Order in this proceeding dated March 4, 1999, Cable Plus Company, LP, doing business in Arizona as Telephone Plus (hereinafter, "Telephone Plus" or the "Company") hereby petitions the Arizona Corporation Commission ("Commission") for its order granting leave to intervene in the above-captioned U S WEST Communications, Inc. ("U S WEST") rate case proceeding. This Application is based upon the following:

1. Telephone Plus has applications pending before this Commission to provide competitive resold and facilities-based local and long distance telecommunications services within the State of Arizona, and the Company is currently providing local exchange services to customers in the Phoenix and Tucson metropolitan areas. Telephone Plus purchases telecommunications services from U S WEST, and the Company's network interconnections with U S WEST's network. Thus, Telephone Plus is directly and substantially affected by the outcome of the U S WEST rate case proceeding.
