**AMENDED RATE CASE  
PROCEDURAL ORDER**

11 **BY THE COMMISSION:**

12 On January 8, 1999, U S West Communications, Inc. ("U S West" or "Company") filed with  
13 the Arizona Corporation Commission ("Commission") a rate application.

14 On February 26, 1999, the Utilities Division Staff ("Staff") of the Commission filed a letter  
15 indicating that U S West's rate application was sufficient and classifying the utility as a Class A  
16 utility.

17 Our March 4, 1999 Procedural Order set the hearing and dates to file testimony.

18 On August 11, 1999, Staff filed a Motion for an Extension of the Dates for Filing Testimony  
19 and Hearing ("Motion").

20 Our August 17, 1999 Procedural Order granted the Motion and filing of testimony but did not  
21 continue the pre-hearing conference that is currently scheduled for October 28, 1999 at 1:30 p.m., at  
22 the Commission's offices in Phoenix, Arizona

23 On September 1, 1999, Teligent, Inc. file an Application for Leave to Withdraw as an  
24 intervenor in the above-captioned docket and reserving its right to file public comments at the  
25 appropriate time.


26 IT IS THEREFORE ORDERED that the pre-hearing conference on the above-captioned


