12 On January 21, 2000 the Arizona Corporation Commission ("Commission") Staff filed a  
13 Motion for an Order Directing U S WEST Communications, Inc. ("U S WEST") to Update its  
14 Schedules ("Motion"). On February 4, 2000, the Company filed its Response to the Motion. On  
15 February 18, 2000, Staff filed its Reply to the Response.


16 On February 2, 2000, MCI WorldCom, Inc. on behalf of its regulated subsidiaries,  
17 (collectively, "MCIW"), AT&T Communications of the Mountain States, Inc. ("AT&T"), and Sprint  
18 Communications Company, L.P. ("Sprint") (collectively "Joint Intervenors") filed a Motion to Sever,  
19 or in the Alternative, to Bifurcate Hearings ("Motion to Sever"). On February 16, 2000, U S WEST  
20 filed a Response to the Motion to Sever. On February 24, 2000, the Residential Utility Consumer  
21 Office ("RUCO") filed a Response to the Motion to Sever.

22 On March 3, 2000, the Joint Intervenors filed a Reply to the U S WEST Response. A  
23 procedural conference was held on March 24, 2000. At that time, a second procedural conference  
24 was set for 2:00 p.m. on April 3, 2000. Due to a scheduling conflict, we find it necessary to change  
25 the date until April 4, 2000.
