Under Decision No. 63487 in this docket and the related Price Cap Plan, Qwest is required to: (i) provide notice to competitors for all new Basket 3 filings [Decision No. 63487, pp. 25:2-4, 26:4-6]; (ii) comply with A.A.C. R14-2-1108 when it desires to combine a Basket 1 service with a Basket 3 service and to include the package in Basket 3 [Id., pp. 25-10-13, 26:4-6]; and (iii) comply with A.A.C. R14-2-1108 when seeking to move a Basket 1 service to Basket 3 [Price Cap Plan, Section 4(i)]. A.A.C. R14-2-1108.A requires Qwest to provide notice to competitors of a Rule 1108 filing.
