**PROCEDURAL ORDER**

10 **BY THE COMMISSION:**

11 On May 30, 2000, Local Gateway Exchange, Inc. ("Applicant" or "LGEI") submitted to  
12 Docket Control of the Arizona Corporation Commission ("Commission") an application for a  
13 Certificate of Convenience and Necessity ("Certificate") to provide competitive facilities-based and  
14 resold local exchange and interexchange telecommunications services in Arizona.

15 On March 30, 2001 (Decision No. 63492), LGEI was granted a Certificate to provide  
16 facilities-based and resold local exchange and interexchange telecommunications services in Arizona.

17 Decision No. 63492 granted LGEI a Certificate conditioned upon the Company filing with the  
18 Commission proof of performance bond in the amount of \$100,000 by April 30, 2001.

19 On July 3, 2001, LGEI filed a request for an extension of time to comply with the filing  
20 deadlines set forth in Decision No. 63492. LGEI is requesting an extension of time until August 15,  
21 2001.

22 On July 6, 2001, Commission Staff indicated that it has no objection to LGEI's request.

23 On August 15, 2001, LGEI indicated they have filed bond requirements with several  
24 institutions and need an extension to October 30, 2001 to file proof of the bond with the Commission.




