PROCEDURAL ORDER

BY THE COMMISSION:

10 On January 16, 2001, the County of Cochise, Arizona ("County") submitted to the Arizona
11 Corporation Commission ("Commission") a request for approval for the construction of a grade-
12 separated crossing of the San Pedro and Southwestern Railway Company ("Railroad") where Bisbee
13 Junction Road crosses the Railroad's tracks in the County, at AAR/Dot No. RR271+32.85. The
14 County requested approval for the construction on behalf of the Railroad. The application was
15 docketed on January 18, 2001.

16 IT IS THEREFORE ORDERED that the request of the County of Cochise, Arizona shall be
17 considered an application for the construction of a grade-separated crossing pursuant to A.R.S. § 40-
18 337, et seq.

19 IT IS FURTHER ORDERED that the Railroad shall be considered the Respondent in this
20 proceeding.

21 IT IS FURTHER ORDERED that the hearing on the application shall be held on February 14,
22 2001, at 9:30 a.m., or as soon thereafter as is practical, at the Commission's offices, 1200 West
23 Washington Street, Phoenix, Arizona.

24 IT IS FURTHER ORDERED that within five business days of receipt of this Procedural
25 Order, the County of Cochise, Arizona shall provide the Railroad, and any other municipality or
26 interested party that may be affected by the application with a copy of the application and this
27 Procedural Order by certified mail.

1 IT IS FURTHER ORDERED that the County of Cochise, Arizona shall file with the
2 Commission's Docket Control proof of compliance with this Procedural Order concurrently with the
3 mailing of notice ordered herein.


