11 **BY THE COMMISSION:**

12 Having considered the entire record herein and being fully advised in the premises, the  
13 Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

14 **FINDINGS OF FACT**

15 1. On October 2, 2000, Julio C. Tanabe ("Applicant") filed with the Commission an  
16 application for a Certificate of Convenience and Necessity ("Certificate") to provide customer-owned  
17 pay telephone ("COPT") service in the State of Arizona.

18 2. In Decision No. 55817 (December 10, 1987), the Commission found that COPT  
19 providers were public service corporations subject to the jurisdiction of the Commission.

20 3. Decision No. 57797 (April 8, 1992) adopted A.A.C. R14-2-901 through R14-2-909 to  
21 regulate COPT providers.

22 4. Decision No. 58535 (February 14, 1994) adopted a Generic Tariff that establishes  
23 rates and minimum service standards applicable to COPT service.

24 5. Pursuant to A.R.S. § 40-282, the Commission may issue Decisions regarding COPT  
25 Certificates without a hearing.

26 6. Applicant has requested that a Certificate be granted and has indicated that it will  
27 provide COPT service pursuant to the rates, terms and conditions specified in the Generic COPT  
28 Tariff.

2 **ORDER**

3 IT IS THEREFORE ORDERED that the application of Julio C. Tanabe for a Certificate of  
4 Convenience and Necessity to provide customer-owned pay telephone service shall be, and is hereby,  
5 approved, conditioned upon Julio C. Tanabe filing a customer information placard approved by the  
6 Director of the Utilities Division for compliance with the requirements of the Generic COPT Tariff  
7 within 60 days of the effective date of this Decision.

8 IT IS FURTHER ORDERED that Julio C. Tanabe shall comply with the terms of the Generic  
9 COPT Tariff, unless otherwise ordered by the Commission.


10 IT IS FURTHER ORDERED that Julio C. Tanabe shall file the following FVRB information  
11 within 18 months of the date that it first provides service. The FVRB shall include a dollar amount  
12 representing the total revenue for the first twelve months of telecommunications service provided to  
13 Arizona customers by Julio C. Tanabe following certification, adjusted to reflect the maximum rates  
14 that Julio C. Tanabe requests in its tariff. This adjusted total revenue figure could be calculated as the  
15 number of units sold for all services offered times the maximum charge per unit. Julio C. Tanabe  
16 shall also file FVRB information detailing the total actual operating expenses for the first twelve  
17 months of telecommunications service provided to Arizona customers by Julio C. Tanabe following  
18 certification. Julio C. Tanabe shall also file FVRB information which includes a description and  
19 value of all assets, including plant, equipment, and office supplies to be used to provide  
20 telecommunications service to Arizona customers for the first twelve months following Julio C.  
21 Tanabe's certification.


1 IT IS FURTHER ORDERED that within 90 days of the effective date of this Decision, Julio


